In this connection, I am to inform you that on the recommendations of the Inspection Committee, the Hon'ble Vice-Chancellor has allowed the grant of provisional affiliation to start B.Sc. (Non-Medical) with Computer Science as one of the elective subjects (20 seats), start B.Sc. (Medical) (20 seats) courses and enhancement of 80 seats in B.A. (Revised Total 240+80=320 seats) & enhancement of 20 seats in B.C.A. (Revised Total 20+20 = 40 seats) courses from the session 2021-2022 to your college, subject to the following conditions imposed by the Inspection committee-

- 1. More regular/approved teachers in each subject and non-teaching staff, especially in lab are required as per KUK norms.
